A MESSAGE FROM THE INTERIM CNO

The Advance Practice Nurse was born in 1965 as the result of the Vietnam War ending with increasing numbers of patients needing access to care. Medicare/Medicaid expanded coverage to low income women, children, elderly and the disabled. By 1973, 65 NP programs were developed across the country. This new controversial role raised questions around the quality of care provided. Mary O'Neil Mundinger answered those questions in her 1994 publication "Advanced Practice Nursing—Good Medicine for Physicians" in *The New England Journal of Medicine* determining that the advanced practice nurse's care was "indistinguishable from their physician counterparts."

Today there are more than 290,000 nurse practitioners across the country. This has grown by 65,000 professionals in just the past 5 years. 134 are employed with us at UCI.

Caring in various practice settings (OR, L&D, Emergency Medicine, Family Medicine, Pediatrics, Critical Care, etc) our advanced practice nurses provide irreplaceable care for our community. Our team functions better because you are with us, contributing to what makes UCI a nationally renowned health care organization.

I continue to be in awe of how our nurses pull together to create a culture of teamwork, service, safety, inclusion, and excellence.

You are our village and thank you for your service.


